VALMEYER PUBLIC LIBRARY DISTRICT ANNUAL TAX LEVY ORDINANCE 2023-12-7 AN ORDINANCE FOR THE LEVY OF TAXES FOR THE TAX YEAR 2021 FOR THE VALMEYER PUBLIC LIBRARY DISTRICT MONROE COUNTY, ILLINOIS

WHEREAS, applicable statutes authorize the Board of Library Trustees to levy taxes for library purposes.

NOW, THEREFORE, BE IT ORDAINED by the Board of Library Trustees of the Valmeyer Public Library District, Monroe County, Illinois, as follows:

SECTION 1: Ordinance No. 2023-12-7 (Budget and Appropriation Ordinance) previously passed by the Board is incorporated by reference.

SECTION 2: A tax in the sum of SIXTY NINE THOUSAND FORTY SIX DOLLARS (\$69,046) is levied upon all taxable property within the corporate limits of the VALMEYER PUBLIC LIBRARY DISTRICT, in Monroe County, Illinois, said tax levied to defray expenses and liabilities of the District for the fiscal year beginning July 1, 2023 and ending June 30, 2024 for specific objects and purposes indicated as follows:
